

ZONING BYLAW AMENDING BYLAW

RURAL MUNICIPALITY OF RECIPROCITY NO. 32

BYLAW NO. 7-23

A BYLAW OF THE RURAL MUNICIPALITY OF RECIPROCITY NO. 32 TO AMEND BYLAW NO. 6-22, KNOWN AS THE ZONING BYLAW

The Council of the RM of Reciprocity No. 32, in the Province of Saskatchewan, enacts to amend Bylaw No. 6-22 as follows:

1. Section 3.4.3(d) shall be amended by adding “iii. Reject the discretionary use application.” Furthermore, the header of Section 3.4.4 shall be amended by removing the typo “reject the discretionary use application.”
2. Section 3.4.4(d) shall be removed and replaced with the new regulation outlined below. Furthermore, Section 3.4.4(e)&(f) shall be removed, which shall change existing Section 3.4.4(g) to Section 3.4.4(e).

“d. If approved, the Development Officer shall send a copy of the OCP or Zoning Bylaw amendment to the Ministry of Government Relations for review. Any OCP or Zoning Bylaw amendment requires Ministerial Approval before it can come into effect.”

3. Section 3.8 is amended by removing Section 3.8.2. Therefore, the regulation under existing Section 3.8.3 shall be changed to Section 3.8.2.
4. Section 4.15 is amended by adding the new regulation outlined below. Therefore, the following regulation under Section 4.15.4 shall be changed to Section 4.15.5.

“Section 4.15.4. Development of new buildings or additions to buildings within the floodway of any watercourse or water body shall be prohibited. Flood proofing of new development to an elevation of, at minimum, 0.5 metres above the 1:500 year flood elevation shall be required.”

5. Table 5 under Section 7.2 shall be amended by changing “Mineral resource, sand, or gravel development” from “Discretionary (D)” to “Permitted (P).”
6. The Table under Section 7.2 shall be amended by adding “Mineral resource, sand, or gravel development” as “Discretionary (D)”.
7. The following table numbers shall be corrected due to a formatting error:

“Table 2 under Section 9.2 shall be changed to Table 11”
“Table 3 under Section 9.2 shall be changed to Table 12”
“Table 4 under Section 9.3.2 shall be changed to Table 13”
“Table 5 under Section 10.2 shall be changed to Table 14”
“Table 6 under Section 10.2 shall be changed to Table 15”
“Table 7 under Section 10.3.2 shall be changed to Table 16”

8. The Zoning District Map under Exhibit A shall be amended by adding the RM seal.
9. This Bylaw shall come into force on the date of final approval by the Minister of Government Relations.
